**History**....CMHC was originally a hospital, founded in 1952. In 1968, a 40-bed nursing home wing was added to the north of the original hospital. The hospital was closed in the late 80's, while the CMHC Nursing Home remained opened. In 2001, Friendship Home Assisted Living was added to CMHC.



**Today**..... Burwell CMHC is a non-profit organization that offers small-town compassionate care with the skill and services equal to that found in large metropolitan areas. Our emphasis is on the resident, their family, and their quality care. Our goal is for all residents to enjoy living to the fullest, at any point in their life. In addition to long-term care we offer Swing Bed Care (short-term Rehabilitation Care), Adult Day Care, Respite Care, Hospice Care, Outpatient Bathing and Transportation Service.
